**INDEMNITY**

I, the undersigned,

hereby declare that I am older than 18 (Eighteen) years of age and that my use of the unregistered runway on the property during my participation in the fly-in event and/or use of the runway for landing, parking or take-off, facilitated by Mattanu Private Game Reserve (*the activity*) controlled, arranged or facilitated by The Trustees Of the Johan Kriek Family Trust (*the owner*), trading as Mattanu Private Game Reserve on the immovable property known as the Farm Mattanu Annex Number 400, District Barkly West (the property), shall at all times be subject to the following conditions:

I fully appreciate the nature of the risks associated with my participation in the activity (comprising of inter alia the use of the private runway on the property) in particular the risk associated with the landing of an aircraft of which I will at the time be in charge of.

1. I acknowledge that I shall participate in the activity voluntarily and at my sole and absolute risk.
2. I have been advised and I acknowledge that I am fully aware:
  - that the length of the runway is 1.15 kilometers
  - that the width of the runway is approximately 13 meters
  - that the aircraft under my control may under no circumstances exceed the weight of 5700 kilograms
  - that I am obliged to inspect the runway before landing by way of low level over flight over the runway
  - That the direction of the runway is 200 & 020 degrees
  - That I shall be fully entitled in my absolute discretion to refuse to participate in the activity.
3. I undertake without question to comply immediately with every lawful instruction issued to me by Mattanu Private Game Reserve or by the owner or any employee or representative of Mattanu Private Game Reserve and to adhere strictly to the safety rules and directives of Mattanu Private Game Reserve.
4. I undertake to conduct myself in accordance with the highest standards of care and responsibility for the health and safety of other persons participating in the activity. and, in particular:

5. In my personal capacity and in my capacity as parent and/or guardian of the minor children named below (*the minors*), I hereby waive all claims against Mattanu Private Game Reserve arising from the loss of or damage to any goods under my/our control or arising from my/our injury or death during the course of our participation in the activities.
6. I indemnify the owner and all employees and representatives of Mattanu Private Game Reserve against all claims (including claims by my dependents) arising from the loss of or damage to any goods belonging to or controlled by me or arising from my injury or death during the course of my participation in the activity.
7. I also indemnify the owner and the employees and representatives of Mattanu Private Game Reserve, as well as their dependents, against any loss, damage or injury which they may suffer as a result of any act or omission on my part.
8. I declare that I will ensure to bring to the attention of my passengers the existence of this indemnity and the risks to which I have been made aware of by using the runway including the alerts recorded under clause 2 above.
